Fast Fleet Systems Fuel Surcharge - Updated Policy

Fast Fleet has adopted a fuel surcharge calculation method based on the fuel prices published weekly by the U.S. Department of Energy. This method most closely links the fuel surcharges to prevailing market prices for diesel fuel, and should help Fast Fleet and its customers respond more quickly to changes in fuel prices in the marketplace. The surcharge percentage for the Fast Fleet System will be subject to monthly adjustment. The adjustment will be made according to the table below and will be based on the price per gallon of diesel fuel stated by the U.S. Department of Energy. We will adjust the surcharge on a monthly basis, based on the national average fuel price posted by the U.S. Department of Energy on the last Monday of each month. The effective periods will run from the first Monday in the succeeding month through the end.
